support gentleman said someone else had also had the same network connection fault in George. He thought maybe Telkom had been doing something on the line; which had disconnected the routers. A while later on the same evening; after I finished reading Tim's linked article to [Socialist Worker: The Terrorists in blue](#)⁸; it occurred again. I did a Google search for the author: Keeanga-Yamahtta Taylor and followed the link to JacobinMag; and it occurred when I clicked on the link to her article: [Black Faces in High Places](#)⁹. Initially the 'network fault' showed the square image with the sad smiley: "This webpage is not available: ERR_CONNECTION_TIMED_OUT". If 'reloaded' it showed the dinosaur: "This webpage is not available. DNS_PROBE_FINISHED_NO_INTERNET" [SS¹⁰]. I did something else: went to lie down or watched a documentary; and when I returned to the internet; it had reconnected; and an 'MWeb landingpage had popped up' [SS¹¹]; which says among others: The MWeb landing page says: "Maximum Concurrent Connections Limit Reached: Error 604. Your login details are already being used for one or more active Internet connections. Please check if your MWEB login details are currently being used from another computer. If you would like us to disconnect a session for you, simply fax us a completed Session Disconnect Form along with a copy of your ID, or a company letterhead if this is your Company's email address, to 021 596 8388.....".

23/05: When I logged on today; the same network fault had occurred with the same sad smiley / dinosaur error messages. A short while later my mom called to say the internet was down; could I please call MWeb to find out what was wrong. I called and spoke to Graham. We had a disagreement when I asked whether it was possible that the MWeb landingpage popup could have been triggered by someone else either attempting to; or managing to sign into the account or hack it. I asked for his manager. I then spoke to the manager: Mr Donovan Williams. He spoke rather fast; so I was not able to write down all he said. He said among others: "He checked the line; it was down... there was a network line fault in the George – Blanco – Rhinefield areas. The network fault occurred this morning at 05:27 am. It can take anything up to 5 to 7 days to fix a network line fault. If it cannot be fixed virtually; Telkom will have to send someone out to fix the line on the telephone pole." He did not think the network faults were a result of NSA and/or KGB or hacker activity. As the call ended, my mom called to remind me to "Don't forget the grass." I then took Mila and Roy for their walk to the forest.
