According to: Guardian: 05 Aug 2015: [Preacher Anjem Choudary charged with encouraging support for Islamic State](#):

Radical preacher Anjem Choudary was charged on Wednesday with encouraging support for the Islamic State militant group. Choudary, 48, appeared in Westminster magistrates court charged with inviting support for a proscribed organisation, namely Isis. It is alleged he committed the offence between 29 June 2014 and 6 March 2015. Another man, Mohammed Rahman, 31, faced the same charge. It is alleged Choudary and Rahman publicised support for Isis and its leader Abu Bakr al-Baghdadi through lectures published online, the court heard. Choudary, a trained solicitor who was previously chairman of the Society of Muslim Lawyers, the married father of five, who lives in Ilford, was dressed in a white ankle-length robe, and told the court he wished to represent himself and pleaded not guilty to the charge; stating "I plead that Cameron and the police are guilty and the only people who are innocent are me and Mr Rahman." Rahman, dressed in a blue hoodie, also pleaded not guilty.

In an earlier statement, Sue Hemming, head of special crime and counter-terrorism at the Crown Prosecution Service (CPS), said: "Following an investigation by the Metropolitan police's counter-terrorism command, we have today authorised charges against Anjem Choudary and Mohammed Mizanur Rahman. "We have concluded that there is sufficient evidence and it is in the public interest to prosecute Anjem Choudary and Mohammed Rahman for inviting support for Isis, a [proscribed terrorist organisation](#), between 29 June 2014 and 6 March this year. Each man is charged with one offence contrary to section 12 of the Terrorism Act 2000. "It is alleged that Anjem Choudary and Mohammed Rahman invited support for Isis in individual lectures which were subsequently published online."

UK v Anjem Choudary EoP Amicus Request:

EoP interpretation of Mr Anjem Choudary's statements and actions as narrated in [Better an Honest Enemy, than a False Friend: Islam4UK's Anjem Choudari agrees with Breivik that Islam and Non-Islam are at War in Europe](#) and [Anjem Choudary backs Remain campaign as EU protects against deportations](#); are that Mr Choudary could possibly be interested in sincerely engaging in brutal honest legal truthseeking enquiry.

Should any UK v Anjem Choudary party consider that an honourable civil factual reality problem solving focused legal EoP v WiP cultural and race war enquiry conversation may be of educational benefit for British citizens and enable greater clarification of British Rule of Law; enabling greater certainty for British citizens; regarding British Rule of Law legal definition of 'terrorism'; I shall be happy to file an Ecology of Peace Amicus to your proceedings.

Honourable civil factual reality problem solving focused; legal race war conversation:

The soldiers have to be able to feel free to speak their minds without worrying about hurting the feelings of the civilians. The civilians have to feel free to speak their minds without hurting the feelings of the soldiers. Then they can bring the EoP v WiP issues that are under the rug out on top of the table and take an intelligent approach to get the problem solved” - Amended: Martin Luther King: [Margaret Sanger Human Rights Award Acceptance Speech 1966](#); Malcolm X: [Make it Plain](#).

In Garrett Hardin's: [Living on a Lifeboat](#) and [Lifeboat Ethics: The Case Against Helping the Poor](#); the basic access to resources leadership decision was 'nations resource lifeboat is not full yet, whom of those drowning in the water; should we give the opportunity to get into our national lifeboat; and whom should we just allow to drown'. EoP Axis: UK v Thomas Mair includes the Ecology of Peace culture legal definition of a 'scarcity combatant'; as noted in EoP PoW draft submission to International Criminal Court: [EoP PoW's –v– Nobel Committee & Peace Laureates et al](#); and notice thereof to ICC: Judges [[PDF](#)]:

The purpose of the Ecology of Peace Applicants educational and legal guerrilla warfare campaign is to nonviolently de-industrialize and reduce consumption and procreation to ecological carrying capacity limits; by implementing an Ecology of Peace international law social contract; that requires all the world's citizens to procreate and consume below ecological carrying capacity limits; and consequently holds breeding and/or consumption scarcity combatants accountable for their 'Crimes of Aggression Acts of War'. Put simply in terms of ICC Prosecutor Luis Moreno-Ocampos [red/green light international law analogy](#); individuals breeding and/or consuming above ecological carrying capacity limits should be considered guilty of procreation/consumption crimes of aggression acts of war; i.e. have crossed the red light.

The Ecology of Peace culture's definition of 'crimes of aggression acts of war' is as follows: "Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international – 'scarcity combatant' social contract; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the 'crime of aggression act of war'."

Carrying Capacity Sustainability: I=PAT Equation:

For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarized by what is known as the Ehrlich or IPAT equation, I=PAT. I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a

sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

An individual's IPAT footprint is a result of: (A) Consumption Footprint multiplied by (B) Procreation Factor.

Consumption Footprint: Consumption footprint calculators are based upon [Global Footprint Application Standards](#), and calculate an individual's consumption footprint based upon various questions about their consumption lifestyle's; and provide a final consumption footprint in global hectares which is the individual's 'consumption footprint'; i.e. the amount of global productive land required for the production of products the individual consumes. Consumption Footprint calculators can be found at among others: [Global Footprint Network](#); [Earth Day](#); [Center for Sustainable Economy](#); [EcoCampus](#).

Global Footprint concepts were developed by among others: Dr. Mathis Wackernagel; Dr. William Rees; Dr. Herman Daly and the Global Footprint Network Standards Committee is one of two committees overseeing scientific review procedures and standards for Footprint calculations.

Procreation Factor: According to the research of [Paul Murtaugh](#): A parent increases their consumption footprint by a factor of 20 for every child procreated.

Carrying Capacity aka Biocapacity Limits: "The maximum number of individuals that can be supported sustainably by a given environment is known as its 'carrying capacity'. Worldwide the total amount of biologically productive land and sea amounts to 12 billion global hectares (gha); or 1.8 gha each if divided by 6.7 billion each. Guerrilla Laws are drawn up in accordance with the proactive conservation policies of Bhutan, who set aside 40% of their biologically productive to be returned to its natural state, for other species and wildlife conservation purposes; then that means that the total amount of biologically productive carrying capacity land available to humans is 60% of 12 billion; which amounts to 7.2 billion gha total; or 60% of 1.8 gha, which is 1 gha each.

Population factor is relevant, because the more humans there are, the less biologically productive land there is for everyone else.

Biocapacity limits of 6.7, 3.5, 1 Billion, 500, 250 & 100 Million humans: 7.2 billion global hectares of biologically productive land and water divided by (a) 6.7 billion humans, equals: 1.07 gha each; (b) 3.5 billion equals 2.05 gha each; (c) 1 billion equals 7.2 gha each; (d) 500 million equals 14.4 gha each; (e) 250 million equals 28.8 gha; (f) 100 million equals 72 gha each.

MILINT Remote Formatting Alterations:

As noted in 05 Aug 2016 1:49 correspondence : [Updates RE: MWeb Legal Dept Notice of immediate termination of Clive Johnstone ADSL account by 14:00 hrs on 05 Aug](#); there were some remote formatting alterations to various EoP v WiP NWO negotiation documents with regard to discussions with MWeb and ISPA; presumably from NSA and/or FSB military intelligence entities; where particular paragraphs or emails had been reformatted from original black text to blue and others grey.

On subsequent days, some of those reformatted coloured paragraphs went from blue to green; and then green to orange; and another went from blue to green to turquoise; the grey one's remained grey. The observations and interpretations were updated at UJMC-SF44: [05 Aug: Remote Formatting Alterations](#).

03 July MWeb blocking of email & ISPA: EoP & WiP; or WiP only:

In the absence of MWeb reactivating the EoP Acting Clerk andreamuhrteyn email account with its password -- as detailed in EoP Applicants: MWeb [PDF] -- it is not possible to ascertain whether my interpretation -- that military hackers who blocked it would reinstate it; when they choose to do so -- was accurate or not.

Succinct Summary of Private Prosecution Complaint:

On behalf of the EoP Applicants I have been preparing documentation for an ICC private prosecution in terms of Rendulic Rule Military Necessity doctrine; CA, UK, US & RSA Common Law Private Prosecution doctrine; Rome Statute: Art.5, 6, 7, 8 & 15; ICC Code of Judicial Ethics: Art 4, 5(1), 7 & 11. Charges: Crimes of Aggression Acts of War.

The Ecology of Peace culture's definition of 'crimes of aggression acts of war' is as follows: "Any individual who is found guilty of advocating on behalf of, legislating, enforcing, or obeying any – cultural, religious, common, statutory, constitutional, or international – 'scarcity combatant' social contract; which enables or advocates on behalf of human procreation, consumption or production of resources that transgress ecological carrying capacity limits, is guilty of the 'crime of aggression act of war'."

Carrying Capacity Sustainability: I=PAT Equation:

For activities to be genuinely sustainable it must be possible for them to continue indefinitely. The impact of humanity on the environment and the demands that people place on the resources available on the planet can be summarized by what is known as the Ehrlich or IPAT equation, $I=PAT$. I = impact on the environment or demand for resources, P = population size, A = affluence and T = technology. The two most important conclusions deriving from this IPAT footprint relationship are that: (i) the Earth can support only a limited number of people, at a certain level of affluence, in a sustainable manner; and (ii) Population and Consumption must be reduced to below carrying capacity.

An individual's IPAT footprint is a result of: (A) Consumption Footprint multiplied by (B) Procreation Factor.

Consumption Footprint: Consumption footprint calculators are based upon [Global Footprint Application Standards](#), and calculate an individual's consumption footprint based upon various questions about their consumption lifestyle's; and provide a final consumption footprint in global hectares which is the individual's 'consumption footprint'; i.e. the amount of global productive land required for the production of products the individual consumes. Consumption Footprint calculators can be found at among others: [Global Footprint Network](#); [Earth Day](#); [Center for Sustainable Economy](#); [EcoCampus](#).

Global Footprint concepts were developed by among others: Dr. Mathis Wackernagel; Dr. William Rees; Dr. Herman Daly and the Global Footprint Network Standards Committee is one of two committees overseeing scientific review procedures and standards for Footprint calculations.

Procreation Factor: According to the research of [Paul Murtaugh](#): A parent increases their consumption footprint by a factor of 20 for every child procreated.

Carrying Capacity aka Biocapacity Limits: "The maximum number of individuals that can be supported sustainably by a given environment is known as its 'carrying capacity'. Worldwide the total amount of biologically productive land and sea amounts to 12 billion global hectares (gha); or 1.8 gha each if divided by 6.7 billion each. Guerrilla Laws are drawn up in accordance with the proactive conservation policies of Bhutan, who set aside 40% of their biologically productive to be returned to its natural state, for other species and wildlife conservation purposes; then that means that the total amount of biologically productive carrying capacity land available to humans is 60% of 12 billion; which amounts to 7.2 billion gha total; or 60% of 1.8 gha, which is 1 gha each.

Population factor is relevant, because the more humans there are, the less biologically productive land there is for everyone else.

For example:

Biocapacity limits of 6.7, 3.5, 1 Billion, 500, 250 & 100 Million humans: 7.2 billion global hectares of biologically productive land and water divided by (a) 6.7 billion humans, equals: 1.07 gha each; (b) 3.5 billion equals 2.05 gha each; (c) 1 billion equals 7.2 gha each; (d) 500 million equals 14.4 gha each; (e) 250 million equals 28.8 gha; (f) 100 million equals 72 gha each.

EoP – the self respect and buck stops here relationship benefits of honesty in a sea of 30 pieces of silver high costs of bullshit – perspective on the benefits and costs of honesty vs lies and bullshit:

Once an individual knows themselves; they are capable of being honest with others and entering into relating experiences that are based upon honest frank relationships; clearly clarifying what they want and what they are capable of giving; to enable honest reciprocity; leading to stronger and more intimate relationships based upon mutual honesty and trust; or enemies who know where they stand with each other.

Better an honest enemy than a false friend. - German Proverb

An enemy, who is honest and shows his/her hate openly is better than a friend who is liar and putting you down secretly. – Unknown

I'd rather have honest enemies than fake friends. – Unknown

Better to be an honest open sinner, than a false saint - Unknown

Wounds from a sincere friend are better than many kisses from an enemy. - Proverbs 27:6

The ultimate outcome of an individual who led an honest or reasonably honest life; may be an individual with few friends; whose relating experiences are to them at least – priceless – in terms of their honesty and sincerity.

Conversely: if an individual is incapable or unwilling to be honest with themselves, regarding who they are; who they want to be; their fears, desires, etc, their entire identity is their bullshit the public relations marketing image.

“I have called this phenomenon the marketing character because it is based on experiencing oneself as a commodity, and one’s value not as ‘use value’ but as ‘exchange value’. The living being becomes a commodity on the ‘personality market’. ... Success depends largely on how well persons sell themselves on the market, how well they get their personalities across, how nice a ‘package’ they are; whether they are ‘cheerful’, ‘sound’, ‘aggressive’, ‘reliable’, ‘ambitious’; furthermore, what their family backgrounds are, what clubs they belong to, and whether they know the ‘right’ people..... must fulfil one conditions: to be in demand. .. The aim of the marketing character is to be desirable under all conditions of the personality market.... The puzzling question why contemporary human beings love to buy and to consume, and yet are so little attached to what they buy, finds its most significant answer in the marketing character phenomenon. The marketing character’s lack of attachment also makes them indifferent to things. What matters is perhaps the prestige or the comfort that things give, but things per se have no substance. They are utterly expendable, along with friends or lovers, who are expendable too, since no deeper tie exists to any of them.” -- Erich Fromm; *To Have or to Be*.

If they are incapable of being honest with themselves; they are incapable of being honest with others; and consequently are incapable of experiencing honest intimate relating experiences; since all their relating experiences are simply different flavours of class, gender, racial or religious passive aggressive bullshit the public relations marketing coolaid sales. The conscious or subconscious suppression of their honest emotions, desires and fears desire to leads to depression and/or search for meaning into conscious and/or unconscious addictions: whether to alcohol, drugs, religion, money, sex, etc.

“I .. suggest that this transformational process requires at least one necessary ingredient without which philosophical counseling would not be possible. Whether implicitly or explicitly, both counselor and client need the virtue of courage in its form as “philosophical courage” in order for the counseling to be successful. Moreover, the degree of such courage in both client and counselor will determine the extent to which issues are brought into question..... there is another form of courage—philosophical courage—required of individuals in dealing with their most fundamental beliefs and values. I believe the best way to demarcate roughly the different forms of courage, is through an analysis of the cost involved with each form of the virtue.... First, with physical courage, the possible cost involved, at the extreme, is the physical loss of life.... Second, with moral courage, the possible cost is social rejection and isolation and/or a loss of “ethical integrity or authenticity”. Third, with “psychological courage,” the possible cost perceived by the individual is “psychic death.” And fourth, with “philosophical courage” the possible cost is philosophical instability where one’s most fundamental beliefs and values are brought into doubt. ... it demands of the individual a confrontation with fundamental beliefs and values”. -- *The Role of Philosophical Courage in Philosophical Counseling*, by Hakam Al-Shawi [PDF]; as quoted in: EoP Clerk to Former EoP Applicant: Francisco Martin [PDF]; 26 Mar 2015; RE: GMC 4643-13; RE: Francisco Martin; Hakam Al-Shawi; CC: RH; RPN; PK; Islamic Scholars.
