I logged into weebly today to do some updates to tygae.weebly.com. I got to the [‘edit site’](#) page; clicked edit to go through to tygae.weebly.com; and it suddenly came up with a new page that said: [‘create a free site with weebly’](#) and a [change button](#). I tried repeatedly using the above features of pages, design and settings to get to tygae.weebly.com pages, but all it showed was [‘create a free site with weebly’](#) with the [change button](#). When I finally clicked on the [create a free site](#); it came up with a [secure ‘upgrade your site’](#) page.

I logged out and tried again twice; and both times, the same pages came up; and I was locked out of my site and unable to access the tygae.weebly.com pages; to edit them. I checked again later; and then it appear that the normal edit function had been restored.

If Weebly has intentions to terminate its ‘free plan’; that’s okay. If so: could you give me a few months, or at least a months notice; so that I can transfer my sites to another service. I cannot afford \$4.95 a month; which in South African terms is about R50.00. That’s approximately what I spend on cellphone for six months.

I have asked readers who visit the visit the site; to make a donation in the past; particularly when I often shared the [Military Intelligence Earth Day Sign Up page](#), whose footer has a financial support statement; of how to provide financial support if they think the information provided is valuable or worthy of financial support. None have done so; but I shall be happy to amend the financial support pdf page; to include a reference to weebly.com for the opportunity you have provided to share the information. Thank you.

If weebly has any problems with the number of my free sites [5] or the content on any of the sites; that is something I can do something about; just let me know; what exactly the concern is; and I will see what I can do.

Weebly: FYI: SQWorms password & Tygae PDF Uploads

On 15 November 2015; shortly after I attempted to log into [SQWorms](#); to post an update to the correspondence to [Dallas Fell](#); copied to [NSA](#) and [FSB](#). I was informed by Weebly log in; that my password was incorrect. So I went through the process of resetting my password; but when I had input the password and then again to confirm it; and pushed enter; it refused me access. I tried twice; and tried again a few days later; and the same thing happened. [\[PNG\]](#)[\[PNG\]](#)

On about 17 November 2015; the PDF upload function on [Tygae](#) was disabled: i.e. the green button which you click to upload a PDF file; was no longer html active; the little html mouse hand sign indicating html active; was replaced by the normal mouse arrow sign [\[PNG\]](#). A few days later it was re-enabled. Then on 22 November it was again disabled; and has remained non-activated since then.

Until it is re-enabled; I have added the following statement next to PDF documents that are unable to be uploaded; at [MILED Clerk Notice](#): “The Weebly PDF upload function has been disabled; either by Weebly tech staff; or other entities. When re-enabled the PDF shall be uploaded” [\[PNG\]](#).

If the SQWorms password and Tygae PDF uploads technical changes are (a) a result of any Weebly decisions; and (b) directed to me; kindly clarify in simple English what your message is; so that I can consider your request and provide you with my response and if necessary reasons; and the matter can be amicably resolved.

If the SQWorms password and Tygae PDF uploads technical changes are not a result of Weebly’s decisions; kindly let me know so that I can amend the statement at [MILED Clerk Notice](#).

If the SQWorms password and Tygae PDF uploads technical changes are (a) a result of other entities; such as NSA, FSB, Mossad or similar; and (b) directed at me and/or Weebly, and/or Tygae readers; then I imagine we shall just have to be patient until we can figure out what their message is exactly.

Lara's Information regarding Timothy McVeigh Faked Execution:

[1] Summary of Timothy McVeigh Faked Execution information I provided to Clive and Ann Johnstone, other Johnstone family members:

[2] ***McVeigh Faked Execution Information:***

[2.1] Sometime between April - December 2001 I informed Demian Johnson that I wanted a divorce; citing my feelings for Timothy McVeigh. Initially Demian was angry and very upset; and had a lot of questions. I answered them as honestly as I was able. We discussed the issue for a few weeks; Demian agreed to an amicable divorce. My divorce paperwork with Demian Johnson was not completed, before I was deported by the Immigration & Naturalization Service in March 2002.

[2.2] Sometime between August 2001 - January 2002 I was informed – in Phoenix and Flagstaff Arizona, Oakland and Berkeley California – by Timothy McVeigh's Special Forces Commanding Officer: Sgt Michael Martin [not his real name]; that McVeigh's 11 June 2001 execution had been faked. Martin had run into McVeigh on the 4th of July weekend; where they had discussed among other issues the OKC bombing and McVeigh's faked execution.

[2.3] Sometime between December 2001 - January 2002 I provided Martin's information to the Office of California Governor Gray Davis; for him to confirm with the White House. Secret Service Steve West informed me that Governor Davis confirmed the information with President George W Bush at a meeting in San Bernadino County. Presumably Governor Davis authorized Steve West to inform me; because Mr. West informed me publicly face to face in the California Governors Office.

[4] ***Responses to McVeigh Faked Execution Information:***

[4.1] ***Clive and Ann Johnstone:***

- A. Sometime in 2002: Clive and Ann Johnstone doubted the information about Timothy McVeigh being alive. So I suggested that they pick up the phone and call the White House. Ann Johnstone then called the White House; with the telephone number I had given her. She asked the White House person who answered the phone; if the people in the White House knew who I was. The man – name unknown or I can't remember – said yes the White House knew who I was; and asked Ann if she knew who my boyfriend was. Ann Johnstone replied: Timothy McVeigh; and the man and Ann then had a short conversation about Lara Johnstone and Timothy McVeigh.
- B. Clive and Ann Johnstone no longer doubt the possibility that McVeigh's execution was faked; but they do doubt that McVeigh cares for me.

- A. None have ever responded with: (a) thank you for the information; or (b) any questions.

[6.2] Timothy James McVeigh born to William "Bill" McVeigh and Mildred "Mickey" Noreen nee Hill; in Lockport New York on 23 April 1968; allegedly executed by the United States Government at Terre Haute Prison; on 11 June 2001, for his involvement in the Oklahoma City Bombing. Current resident information unknown; possible information he is employed by the National Security Agency, resident either at Ft Meade or somewhere in Anne Arundel Co. [6.4] Michael Martin [not his real name] a GreenEyed Seminole Indian, born on Seminole reservation in Florida; Timothy McVeigh's US Army Special Forces Commanding Officer, John Doe #2 co-conspirator in the Oklahoma City Bombing; ordered by the United States Army to disappear after the OKC bombing. Contact details unknown.

[6.5] Joseph Graham "Gray" Davis, Jr. born 26 December 1942 to Joseph G Davis and Doris Meyer Morell in the Bronx, New York City, who served as the 37th Governor of California from 1999 to 2003. He is currently practicing corporate law as "of counsel" to Loeb & Loeb in Century City, California. His email address is: gdavis@loeb.com

[6.6] George Walker Bush born to George Herbert Walker Bush and Barbara Bush nee Pierce in New Haven, Connecticut; on 06 July 1946, who served as the 46th Governor of Texas from 1995 to 2000, and the 43rd President of the United States from 2001 to 2009. President Bush was presumably the individual who – either of his own volition; or under threat from one or more other individuals; if so presumably U.S. Military officials, Vladimir Putin, Benjamin Netanyahu and/or Pope Benedict XVI -- made the decisions related to Timothy McVeigh's 11 June 2001 faked execution; the exact details of those decisions remain unknown to the applicant. GW Bush currently lives on his farm in Crawford Texas. If or when Applicant has information related to her efforts to remove the legal obstacles preventing Timothy and the applicant from being together she provides such information to President Bush via his Secretary of Defence: Donald Rumsfeld whose email address is: daniel@javelindc.com. [9.6] Terry Nichols: Nichols was a farmer, grain elevator manager, real estate salesman, ranch hand and soldier before he was convicted as McVeigh's accomplice in the Oklahoma City bombing. Nichols was sentenced to 161 consecutive life terms without the possibility of parole, and is incarcerated at ADX Florence, a super maximum security prison near Florence, Colorado. He shares a cell block that is commonly referred to as "Bombers Row" with Ramzi Yousef: convicted of being the mastermind of the 1993 World Trade Center bombing, bombing of Philippine Airlines Flight 434, and a co-conspirator in the Bojinka plot; and Ted Kaczynski also known as the Unabomber; an American anarchist convicted of a nationwide bombing campaign against people involved with modern technology. It was restored immediately after (i) I sent an email to What A Way To Go: Life at the End of Empire, producer: Timothy Scott Bennett; copied to Lawrence Wilkerson and Arif Hasan Akhundzada Khan; a copy of which can be found in: *EoP v WiP NWO negotiations Legal Correspondence to International Psychiatry and Psychology Organisations* [PDF]; and (ii) I moved my mouse over the green button; and it still had the non-html active arrow; but I saw that when I moved it over the border of the green button; then for a split-second it would have an html-active-hand signal.

Then I thought; instead of clicking on the button; I could see whether the drag and drop upload function was also not working. I had not used it before; so I tried that and then it started uploading; and immediately thereafter the html-active-finger was active over the entire green button area; not just for a split second on the border. In the – amended – wording of Dr. Al Bartlett: Living on a planet where cultures are based upon Masonic War is Peace right to breed/consume social contract principles is like buying a ticket on the Titanic; if you're smart you go Capitalist first class; or you can go cheap Communist or Primitivist steerage third class. In all cases, the sinking of the culture from ecological overshoot resource depletion result is the same. But if the social contract gives the people the choice, most people would go fast, flashy and first class.

As reported in Nasa funded [Human \(Predator\) and Nature \(Prey\) Dynamics \(HANDY\) studies](#): Humans who engage in [totalitarian agriculture](#), engage in Predator-Prey Growth and Collapse of Civilization/Empire cycles: Greco-Rome, Minoan, Mycenaean, Sumerians, Akkadian, Assyrian, Babylonian, Achaemenid, Seleucid, Zhou, Han, Tang, Song, Parthian, Sassanid, Umayyad, Abbasid, Mauryan, Gupta, Maya, Hittite, Harrapan and Teotihuacan.
